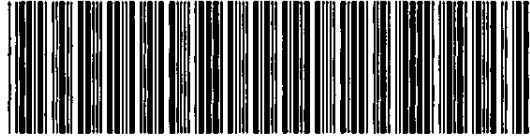

The street and mailing address of the principal office of the Company is 3599 University Blvd. South, Suite 601, Jacksonville, Florida 32216.


ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS


