## Amended and Restated Articles of Incorporation

## Associates in Dermatology, P.A.

The undersigned, acting in his capacity as the President of Associates in Dermatology, P.A. (the "Corporation"), a Florida corporation, on behalf of the Corporation, has executed these Amended and Restated Articles of Incorporation ("Amended and Restated Articles"), as approved and adopted in an action by written consent of the sole member of the Board of Directors and the sole Shareholder of the Corporation pursuant to Florida Statutes Sections 607.0821 and 607. 0704.

These Amended and Restated Articles amend and restate in the entirety the Corporation's Articles of Incorporation, as filed with the Florida Department of State on September 6, 1989. The Amended and Restated Articles reflect the change of the Corporation's name from Associates in Dermatology, P.A. to Associates in Dermatology, Inc. and removes the Corporation from the provisions of Chapter 521, Florida Statues.
