**ARTICLES OF ORGANIZATION  
OF  
MV RECREATIONAL, LLC,  
A Florida Limited Liability Company**

**ARTICLE I  
Name**

The name of the limited liability company ("Company") is MV RECREATIONAL, LLC.

**ARTICLE II  
Address**

The mailing and street address of the Company's initial principal office is 121 South Orange Avenue, Suite 850, Orlando, Florida 32801.

**ARTICLE III  
Duration**

The Company shall have a perpetual existence, unless dissolved upon the written consent of all of its Member(s) or on the occurrence of the death, bankruptcy, resignation, or expulsion of the last one of its Member(s). If, however, within the following 90 days, the personal or other legal representative of the last remaining Member agrees in writing to continue the Company and agrees to the admission of it or its nominee as a Member, effective as of the occurrence of the event that terminated the continued Membership of the last remaining Member.

**ARTICLE IV  
Registered Agent and Office**

Continuation of Company
