Elio Guerrero.

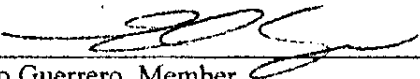

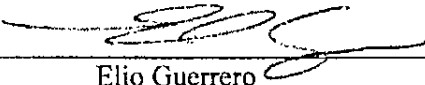
