ARTICLES OF ORGANIZATION OF KOTILA SPINE & JOINT CENTER OF BRANDON, LLC

Article I - Name and Duration

The name of this Limited Liability Company is KOTILA SPINE & JOINT CENTER OF BRANDON, LLC, (hereinafter referred to as the "Company"). The duration of the Company shall be perpetual, commencing as of the date signed below or when accepted for filing by the Secretary of State.

Article II - Principal Office

The mailing address and street address of the principal office of the Company 1451 Oakfield Drive, Brandon, Florida 33511, or such other place as the Members may determine from time to time.

Article III - Registered Office and Agent

The address of the registered office of the Company in the State of Florida is 1451 Oakfield Drive, Brandon, Florida 33511. The name of the registered agent at such address is Gary Kotila.

Article IV - Company Purposes, Powers and Rights

- 1. The nature of the business to be conducted or promoted and the purposes of the Company are to deliver health care services and any and all other purposes permitted by law or otherwise authorized by Section 605.0108, Florida Statutes.
- 2. The Company shall have all of the powers granted to a limited liability company under the laws of the State of Florida, including, without limitation, the powers specifically enumerated in Section 605.0109, Florida Statutes.
- In furtherance of its purposes, the Company shall have all of the general and specific powers and rights granted to and conferred on a company under the laws of the State of Florida, including, without limitation, the powers specifically enumerated in Section 605.0109, Florida Statutes.

Article V - Members

1. The initial members of the Company (the "Members") are set forth in the Company's records dated as of the date hereof and include:

Additional Members may be admitted from time to time only upon the written consent of all of the Members, and under the terms and conditions upon which such consent may

be conditioned.

Article VI - Amendment

The Members shall have the right to amend, alter, change or repeal any provision contained in these Articles of Organization, in the manner now or hereafter prescribed by a written agreement among the Members and all rights conferred upon Members herein are granted subject to this reservation.

Article VII - Regulations

The power to adopt, alter, amend or repeal an Operating Agreement (Regulations) for the management of this Company shall be vested in the Members.

Article VIII - Transferability of Members' Interest

A Member's interest in the Company may be transferred only with the unanimous written consent of all the remaining Members if the transferee intends to become a Member. Subject to the terms of a written agreement among the Members, without such consent, the transferee shall not be entitled to become a Member of the Company, but shall be entitled only to the share of profits, other compensation or return of contributions to which the transferror otherwise would be entitled.
