Articles of Organization

1106 Buttonwood, LLC

A Florida Limited Liability Company

- Name. The name of this limited liability company is 1106 Buildinwood LLC (the "Company"), and it shall be formed as a Florida limited liabilityr-company under Chapter 605, Florida Statutes.
- Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
- The mailing address and street address of the Place of Business. Company's principal office is 1380 Royal Palm Square Boulevard, Fort Myers, Florida 33919.

- Certificated Interests. The members' interests in the Company may be evidenced by certificates.
