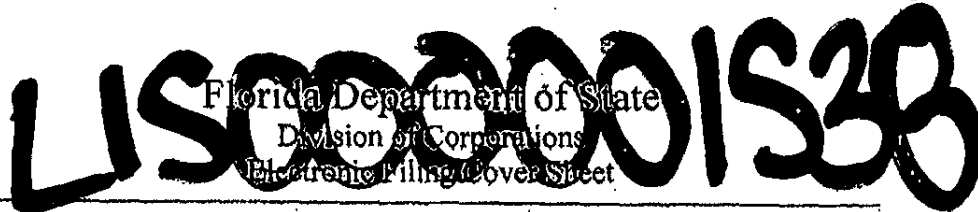

**ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
OF  
OLD WINTER GARDEN ROAD, LLC  
a Florida limited liability company**

The undersigned, in his capacity as the manager of **OLD WINTER GARDEN ROAD, LLC**, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company dated December 22, 2014 (the "Articles of Organization") pursuant to Section 605.0202., Florida Statutes, hereby states as follows:

1. The name of the Company is – Old Winter Garden Road, LLC.

3. The Articles of Organization are hereby amended as follows:
  - a. Article IV is hereby deleted in its entirety and replaced by the following:

The Company is to be managed by managers. The managers shall be elected in the manner described in the operating agreement of the Company.
4. The foregoing amendment to the Articles of Organization is effective as of the date of filing of these Articles of Amendment with the Florida Department of State (the "Effective Date"), and was approved by the written action of all of the members of the Company.
