WHEREAS, effective January 5, 2015, the Member executed Articles of Organization with respect to Wireless Investments, LLC, a Florida limited liability company (the "Company");

WHEREAS, the Members wish to amend again to change the Managers and the Members; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Members agree as follows:

2. The Articles of Organization is hereby amended as follows:

2.1 Basem Ali shall own 50% interests in the Company and Reem Ali shall own 50% interests in the Company.

2.2 Exhibit "A" is amended to set forth the names of the Members of the Company, and their respective units, initial contribution and profit percentage, as of the effective date hereof.

2.3 Manager shall now be Basem Ali.

3. This Amendment, supersedes any and all prior agreements (written and oral) with respect to the matters covered herein and therein. This Amendment shall not be amended or added to in any


