**AMENDMENT TO THE ARTICLES  
OF ORGANIZATION OF  
JG OPERATIONS OF WORLD GOLF VILLAGE FLORIDA, LLC**

The undersigned, for the purpose of amending the Articles of Organization of JG OPERATIONS OF WORLD GOLF VILLAGE FLORIDA, LLC pursuant to §605 of the Florida Limited Liability Company Act, F.S., hereby makes, acknowledges, and files this Amendment to the Articles of Organization of JG OPERATIONS OF WORLD GOLF VILLAGE FLORIDA, LLC. The original Articles of Organization were filed with the Florida Department of State on January 6, 2015. The Amendment is set forth as follows:

1. The name of this Company is JG OPERATIONS OF WORLD GOLF VILLAGE FLORIDA, LLC.

2. The Articles of Organization of JG OPERATIONS OF WORLD GOLF VILLAGE FLORIDA, LLC have been amended by deleting Article V in its entirety and by substituting in lieu thereof the following Article:

**"Article V - MANAGEMENT"**

The Company shall be managed by a Manager. The Manager as of the date of this Amendment is Garrett Schanck, who shall manage the Company in accordance with the terms of the Operating Agreement of the Company, if any, and applicable law.

3. The referred to Amendment was adopted by the Company on August 25, 2015, by all of the Members of the Company.

4. Upon the filing of these Articles of Amendment by the Department of State, the above referred to Amendment shall become effective and the Articles of Organization of JG OPERATIONS OF WORLD GOLF VILLAGE FLORIDA, LLC shall be deemed to be amended accordingly.
