The undersigned, for the purpose of forming a multi-member limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND ADDRESS

The name of the limited liability company shall be PHIL HOUSE CONSULTING, LLC ("Company"). The principal place of business of the Company in Florida shall be 2601 SE 40th Street, Ocala, Florida 34480.

ARTICLE II
DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization or the laws of the State of Florida.

ARTICLE III
PURPOSES AND POWERS

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The Company shall initially have two (2) Managers, a President, Chief Financial Officer ("CFO") and a Vice President of Sales. Any Manager or Officer may sign any and all documents on behalf of the Company, including but not limited to documents to sell and convey, to borrow money and to grant a security interest in assets of the Company.
