
ARTICLE VI

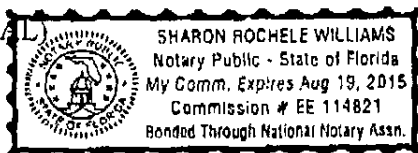
