
ARTICLE VI

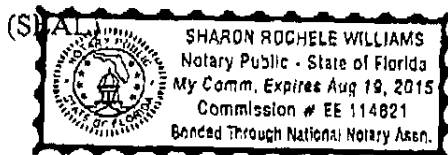


