**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
BRANDON AFFORDABLE PARTNERS GP, LLC**

The undersigned, as the manager of Brandon Affordable Partners GP, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 605, Florida Statutes, the Florida Revised Limited Liability Company Act (the "Act"), states as follows:

1. The current name of the Company is Brandon Affordable Partners GP, LLC.
2. The date of the filing of the original Articles of Organization of the Company was January 6, 2015.
