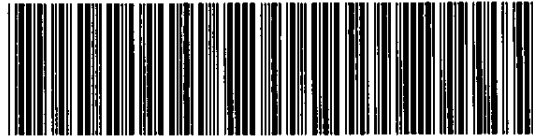

ARTICLE 1 - NAME

The name of the limited liability company shall be **MEL'S BLVD. CAFE L.L.C.** ("Company").

ARTICLE 2 - ADDRESS




