ARTICLE V - Purpose:

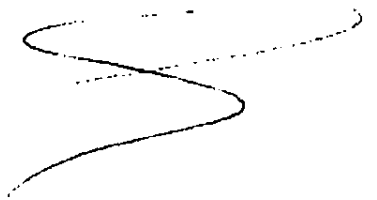
The business of the Company shall be to engage in any lawful act or activity permitted to a limited liability company under the laws of Florida.

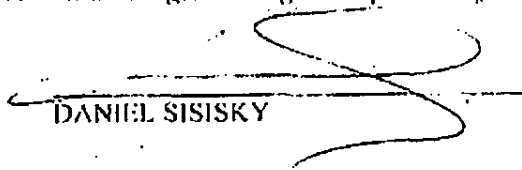
