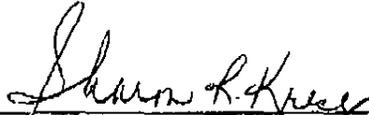

ARTICLE 7 OPERATING AGREEMENT AND AUTHORITY

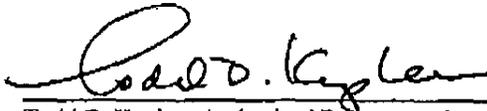
