ARTICLE I - NAME

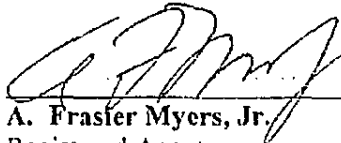
ACCEPTANCE OF APPOINTMENT OF REGISTERED AGENT
