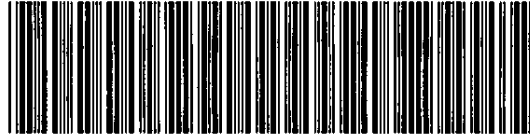

Article IV: The management of Auto Depot of Navarre, LLC shall be vested in the members.




