**ARTICLES OF ORGANIZATION
OF
VETFOLIO, LLC**

ARTICLE I

Name and Duration

The name of this limited liability company is VETFOLIO, LLC (hereinafter referred to as the "Company"). The duration of the Company shall commence upon the filing of these Articles of Organization and shall be perpetual.

ARTICLE II

Principal Office

The mailing address and street address of the principal office of the Company is 5003 SW 41ST Boulevard, Gainesville, Florida 32608, or such other place as the members of the Company may determine from time to time.

ARTICLE III

Registered Office and Agent

The address of the registered office of the Company in the State of Florida is 200 South Orange Avenue, Suite 2300, in the City of Orlando, County of Orange, State of Florida 32801. The name of the registered agent at such address is A.G.C. Co.

ARTICLE IV

Purpose

The purpose of the Company is to exercise all of the powers granted to a limited liability company under the laws of the State of Florida, including, without limitation, the powers specifically enumerated in Section 605.0109 of the Act, subject to the limitation that the Company shall only engage in activities that further the charitable and educational purposes of Eastern States Veterinary Association, Inc., a Florida not-for-profit corporation doing business as North American Veterinary Community ("NAVC"), as well as the educational purposes of American Animal Hospital Association, an Illinois non-profit corporation ("AAHA"), and the Company shall not engage in any activity that could jeopardize the tax-exempt status of NAVC or AAHA.




