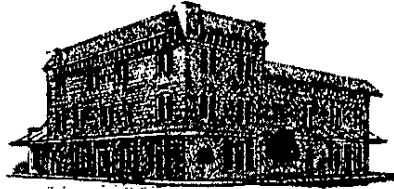

A. The name of this limited liability company is OLD FLORIDA RIVERFRONT PROPERTIES, LLC (the "Company").


B. The Company shall be dissolved effectively upon filing of these Articles of Dissolution with the Secretary of State for the State of Florida.


C. The Company is being dissolved upon the unanimous written consent of all of the Members of the Company. As evidence thereof, all Members have executed these Articles of Dissolution.
