ARTICLE V ~ Perpetual Duration

The period of duration of NVBH ORANGE, LLC #3 is perpetual.

ARTICLE VI - Form of Management

The management of NVBH ORANGE, LLC #3 shall be vested on the members pursuant to the Operating Agreement.

ARTICLE VII - Purpose

The purpose of the company is to engage in any lawful or activity for which an LLC may be organized under the laws of Florida and the United States.

ARTICLE VIII - Indemnification

- (a) The company shall indemnify every manager, and the manager's heirs, executors and administrators, against expenses actually and reasonably incurred by the manager, as well as against any amount paid upon a judgment in connection with any action, suit, or other proceeding, civil or criminal, to which the manage: may be made a party by reason of having been a manager of this professional limited liability company.
- (b) This indemnification is being given because the manager(s) will be requested by the company to act for and on behalf of the company and for the company's benefit.
- (c) This indemnification is not exclusive of other rights to which the manager(s) may be entitled.
- (d) The manager(s) are entitled to the fullest indemnification allowed by the current law or as the law may be amended after the adoption of these articles.
- (e) A manager shall be liable to the company for the following actions:
 - (1) Any breach of his or her duty of loyalty to the company, or to its members;
 - (2) An act or omission that was taken in bad faith and which constitutes a breach of the Manager's duty to the company by an act that is grossly negligent, malicious, or intentional, as those terms are defined at law;
 - (3) A transaction in which the manager benefits to the detriment of the company or its members.
 - (4) An action for which the manager is liable at law and for which an indemnification is not allowed.

ARTICLE IX - Operating Agreement

The Operating Agreement will establish the duties and responsibilities of each authorized member as well as method of distribution of profits and liability for expenses. In the event of conflict between the Operating Agreement and the Articles of Organization, the Operating Agreement will govern.

ARTICLE X - Right To Continue Business

In the event of the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in NVBH ORANGE, LLC #3, the remaining members have the right under the operating agreement to continue the business of NVBH ORANGE #3, LLC.

ARTICLE X1 - Certificate of Membership

A member's interest in NVBH ORANGE, LLC #3, may be evidenced by a certificate of membership interest signed by the Authorized Member of the LLC, which may be assigned or transferred. The right to assign or transfer a member's interest in NVBH ORANGE #3, LLC is limited by the provisions of the Operating Agreement.
