ARTICLES OF ORGANIZATION OF RAPID ESTATE LIQUIDATORS, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the in accordance with Florida Revised Limited Liability Company Act (Florida Statutes Chapter 605).

ARTICLE I - NAME

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a Member in Rapid Estate Liquidators, LLC, the remaining Members may, by unanimous agreement, continue the business of Rapid Estate Liquidators, LLC.

Rapid Estate Liquidators, LLC is to be managed by its Member and the name and address of the individuals who will serve as the Managing Member is:

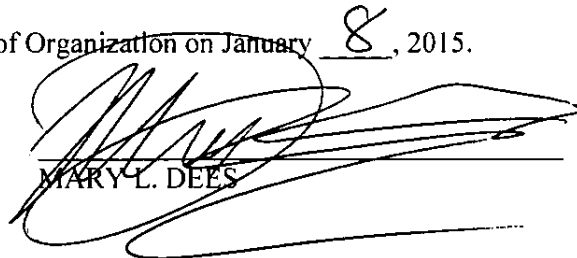
