**Continuation Provisions**

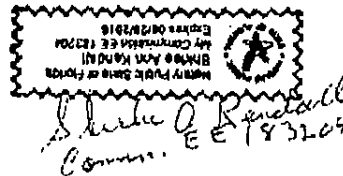

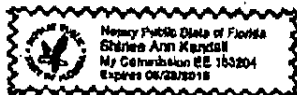
