Garrett McNeil, a natural person competent to contract and a member of Deer Lake Investors, LLC, hereby presents these Articles of Organization as the Articles of Organization of Deer Lake Investors, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Deer Lake Investors, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."


