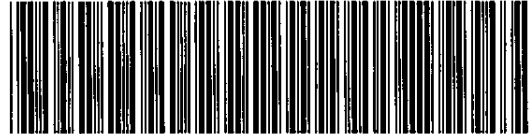

**ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 605, Florida Statutes, the undersigned being authorized to execute and file these Articles, adopts the following Limited Liability Company Articles of Organization:

ARTICLE I - NAME

The name of this Limited Liability Company is the MOODY LAND & TIMBER, LLC.

ARTICLE II - MAILING ADDRESS AND STREET ADDRESS

The members of this limited liability company have the right to admit additional members to this organization upon the unanimous consent of those individuals or entities who are members prior to the admission of the new member.


ARTICLE VIII - CONTINUATION OF BUSINESS
