ARTICLES OF ORGANIZATION

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, **3345 OLEANDER WAY, LLC**, a Florida limited liability company ("*Company*"), through the undersigned, as its authorized representative, certifies that:

A. The Articles of Organization of the Company were filed by the Florida Department of State on January 23, 2015, and assigned Florida document number L15000013713.

B. The Articles of Organization were amended and restated in their entirety and filed by the Florida Department of State on January 29, 2015 (the "*Amended and Restated Articles of Organization*").

C. The Amended and Restated Articles of Organization are amended and restated in their entirety to read as follows:

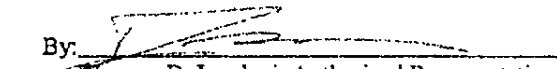
1. NAME: The name of the Limited Liability Company is: 3345 OLEANDER WAY, LLC.

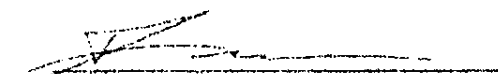
