Dear Ms. Audrey Bracho:

I am writing to inform you that in accordance with Fla. Stat. 605.0216, I resign from my Manager position of So Dharma LLC effective today, despite complete ignorance on my behalf as to the assignment of this position because of the simple fact that I never expressly nor impliedly accepted it.

Accordingly, the reasons for my resignation are as follow:

1. First, I was completely unaware of the existence of this position and even less that I was a Manager in this company. This sort of arbitrary decisions may entitle me to a right of action for damages against you.
2. Second, I have not received any payment whatsoever as proof of any labor or commercial relationship with this company.
3. Third, I witnessed how you on behalf of this company engaged in unfair and deceptive trading practices that are clearly contrary to my work ethics and personal values.
4. Fourth, even though I was completely ignorant of this unilaterally assigned position, you have not respected my personal opinion regarding the management and executive decisions you made within this company.

5. In addition to this, you are the registered agent of this company and as such you declared that you were a Florida resident even though you are not. You must reside in the state of Florida in order to be a legal registered agent of a Florida LLC. Thus you are in flagrant violation of Fla. Stat. 608.415. This sort of deceitful action also has legal consequences that are detrimental to you.
6. Lastly, you are well aware that because of your unfair and deceitful practices you persuaded me to invest over \$25,000 (Twenty five thousand American dollars) in your fraudulent business, therefore unless this situation is remedied by the return of the before mentioned amount within the next ten (10) calendar days, I shall legally pursue all claims necessary to recover my initial investment along with all the corresponding damages according to Federal and Florida Law. You are hereby **formally on notice of this intention. Please govern yourself accordingly.**

I think it is in my best interest to show that you are fully aware of this situation and that despite my unsuccessful attempts to amicably resolve this embarrassing situation you have gotten yourself into, all you have done is threaten to physically harm me. Such threats shall also carry legal consequences.
