**ARTICLES OF ORGANIZATION  
OF  
GFElectro, LLC**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, does hereby adopt the following Articles of Organization.

**Article 1. - Name**

The name of the limited liability company is GFElectro, LLC (the "Company").

**Article 2. - Commencement & Duration**

The Company shall commence upon the filing with the Florida Department of State and shall continue to exist perpetually.

**Article 3. - Company Address**

The street address of the Company's principal office is 7603 Oakmoor Dr., Tampa, Florida 33634, and the mailing address of the Company is the same.

**Article 4. - Registered Office & Agent**
