PLAN OF MERGER OF

LE MACARON FRENCH PASTRIES CONFECTIONERY LLC, WITH AND INTO LE MACARON CONFECTIONARY, LLC

- LE MACARON FRENCH PASTRIES CONFECTIONERY LLC, a Florida member-managed limited liability company, and LE MACARON CONFECTIONARY, LLC, a Florida manager-managed limited liability company, hereby adopt and approve the following plan as the Plan of Merger required by Section 605.1022, Florida Statutes. The terms of the Plan of Merger are as follows:
- 1.
