ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF TAMPA BAY JAW AND FACIAL SURGERY OF WESLEY CHAPEL PLLC

Pursuant to the provisions of Section 605.0202 of the Florida Statutes, Tampa Bay Jaw and Facial Surgery of Wesley Chapel PLLC (the "Company"), has adopted the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the company is Tampa Bay Jaw and Facial Surgery of Wesley Chapel PLLC.

SECOND: The Articles of Organization were filed by the Company on January 29, 2015 and assigned document number L15000017613.

THIRD: The following amendment to the Articles of Organization has been adopted by the Company:

Article I of the Articles of Organization of the Company is hereby amended by deleting such Article, in its entirety and substituting in lieu of such Article the following: new Article I which reads as follows:

ARTICLE I NAME

The name of the limited liability company is TAMPA BAY JAW AND RACIAL SURGERY OF WESLEY CHAPEL, LLC.
