MANAGEMENT**

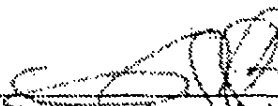

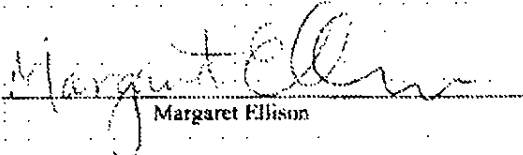
