**ARTICLES OF ORGANIZATION
OF
GMC RIDGEWOOD MANAGER, LLC**

The undersigned organizers, who are members of GMC RIDGEWOOD MANAGER, LLC ("Company") under the Florida Revised Limited Liability Company Act, hereby adopt the following Articles of Organization.

ARTICLE I - NAME

The name of the Company is GMC RIDGEWOOD MANAGER, LLC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address and street address of the Company is 4821 Atlantic Boulevard, Jacksonville, Florida 32207.

ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

ARTICLE IV - MANAGEMENT


