ARTICLES OF ORGANIZATION
OF
BALL 3M, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is BALL 3M, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 4025 Azure Way, Pensacola, Florida 32507, and its mailing address is 4025 Azure Way, Pensacola, Florida 32507, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE III
MANAGEMENT

The business of the Company shall be managed by a Manager selected by the Members. The initial Manager shall be MARILYN F. BALL, 4025 Azure Way, Pensacola, Florida 32507, who shall serve as the sole Manager of the Company until her resignation or death, or as otherwise provide in the Operating Agreement of the Company.

ARTICLE IV
RESTRICTIONS ON MEMBERSHIP

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members and the Manager.


