**ARTICLES OF ORGANIZATION
OF
BIG BIB DEVELOPMENT, LLC**

The undersigned authorized representative of a member hereby executes these Articles of Organization (the "Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

ARTICLE III


affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.
