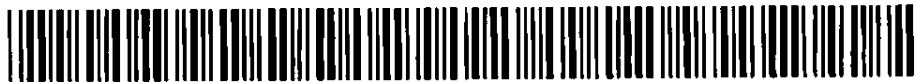

The Articles of Organization were filed on July 8, 2019 and assigned document number E15000019013.




