

ARTICLES OF ORGANIZATION

ARTICLE VII. INITIAL CAPITAL CONTRIBUTION AND OWNERSHIP INTEREST

Voting power hersunder shall be exercised based on the percentage ownership interests of the Members. All decisions of determinations of the Limited Liability Company shall be made in accordance with the wishes of the holders of the majority ownership interest in the Limited Liability Company.
