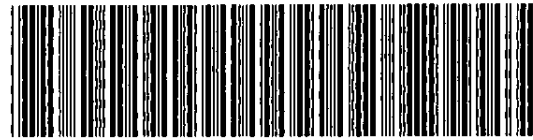

ARTICLES OF ORGANIZATION
OF
FLORIDA ORTHOPAEDIC TRAUMA SPECIALISTS, PLLC

The undersigned hereby certifies that he is the Authorized Representative of a Member who is forming a Professional Limited Liability Company under Florida Statutes Chapters 605 and 621. The following Articles of Organization are hereby adopted.

ARTICLE 1.
NAME

The name of the Professional Limited Liability Company shall be Florida Orthopaedic Trauma Specialists, PLLC.

ARTICLE 2.
DURATION; EFFECTIVE DATE

This Professional Limited Liability Company shall exist perpetually, commencing as of February 2, 2015.

ARTICLE 3.

ARTICLE 4.


