ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - Name: The name of the Limited Liability Company is : TRADER K, LLC

ARTICLE II - Address: The mailing address of the principal office of the Limited Liability Company is: 8205 N.W. 66th Street, Miami, Florida 33166.

ARTICLE III: This Limited Liability Company is organized for each and every legal and lawful purpose for which a Limited Liability Company may be organized pursuant to the Florida Limited Liability Company Act, and shall have and may exercise all powers and rights which a Limited Liability Company may exercise under Florida law or the laws of the United States of America.

The general nature of the business and the objects and purposes to be performed and carried on are to do any and all things allowed and permitted to be done by Limited Liability Companies under the Statutes of the State of Florida, and to do any of the following activities, to wit:

a) to engage in any and all activities related to the procurement, installation, maintenance and service of commercial kitchens and foodservice equipment including complete warehousing, delivery, setting-in-place and assembly of equipment and commercial refrigeration and ventilation systems and to engage in any and all activities related to the procurement, installation, maintenance and service of equipment, supplies and furniture for the hospitality industry, including all types of hotels and motels, and deal in all fixtures, machinery, apparatus, accessories, tools, materials, products and merchandise incidental or related thereto, or of use therein.

b) to export from and import into the United States of America and its territories and possessions, and any and all foreign countries, as principal or agent, general merchandise, and to purchase, sell and deal in and with, at wholesale and retail, merchandise for exportation from and importation into the United States, and to and from all countries foreign thereto, and for exportation from and importation into any foreign country, and to purchase and sell domestic and foreign merchandise in foreign markets, and to do a general foreign and domestic exporting and importing business; to carry on and conduct a general purchase and sale business; to distribute, deliver, purchase and sell goods, wares, merchandise, property and other articles of commerce, promoting sales by advertising, and contracting for the sale, introduction, advertisement and use of services of all kinds, related to any and all kinds of businesses for any and all purposes.

c) to carry out any or more of the purposes and objects herein enumerated as principal, factor, agent, contractor, or otherwise, either alone or thorough or in conjunction with any person, partnership, association or corporation.

d) to carry on its operations and conduct business in any State, in the District of

Columbia, in any territory, dependency or possession of the United States, and in any foreign country.

e) to such extent as a Limited Liability Company organized under the Laws of the State of Florida may now or hereafter lawfully do, to do, either as principal or agent, and either alone or in connection with limited liability companies, corporations, firms or individuals, all and everything necessary, suitable, convenient, or proper for, or in connection with, or incidental to, the accomplishment of any of the purposes herein enumerated, or designed directly or indirectly to promote the interests of this Limited Liability Company or to enhance the value of its properties; and in general, to do any and all things and exercise any and all powers, rights and privileges which a Limited Liability Company may now or hereafter be organized to do or to exercise under the Laws of the State of Florida or under any act amendatory thereof, supplemental thereto, or substituted therefore.

The foregoing clauses shall be construed as and shall be powers as well as purposes, and the matters expressed in each clause shall, unless otherwise herein expressly provided, be in no way limited by reference to or in reference from the terms of any other clause but shall be regarded as independent powers and purposes; and the enumeration of specific powers and purposes shall not be construed to limit or restrict in any manner the meaning of general terms or the general powers of this corporation, nor shall the expression of one thing be deemed to exclude another not expressed, although it be of like nature.

This Limited Liability Company shall be authorized to exercise and enjoy all other powers, rights and privileges granted by the Laws of the State of Florida, and all the powers conferred by all acts heretofore or hereafter amendatory or supplemental to those Laws, provided, however, that nothing herein contained shall be deemed to authorize or permit this Limited Liability Company to carry on any business, to exercise any power or to do any act which a Limited Liability Company may not at the time lawfully carry on or do.

ARTICLE IV: The maximum number of units that this Limited Liability Company is authorized to have outstanding at any time is One Thousand (1,000) units of \$1.00 par value.

ARTICLE V: The amount of capital with which this Limited Liability Company will begin business shall be no less than \$1,000.00.



ARTICLE XI- Amendments:


This Limited Liability Company reserves the right to amend, alter or repeal any provision contained in these Articles of Organization in accordance with the Florida Limited Liability Company Act.


