**ARTICLES OF ORGANIZATION
OF
ESTHETICS CENTER OF SOUTH MIAMI LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I. NAME

The name of the limited liability company is Esthetics Center of South Miami LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 7300 SW 62nd Place, 3rd Floor, South Miami, Florida 33134.


