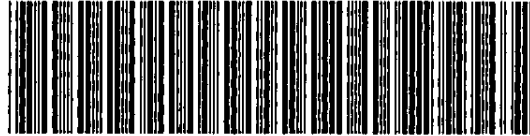



of

A Florida Limited Liability Company

ARTICLE 1
NAME

The name of this limited liability company is GDAF Lakeland, LLC.


