**ARTICLES OF ORGANIZATION  
OF  
OCEANSIDE PRIVATE PRACTICE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I – Name**

The name of the Limited Liability Company is OCEANSIDE PRIVATE PRACTICE, LLC (the "Company").

**ARTICLE II – Address**

#### ARTICLE VIII – Termination of Existence


