**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
5900 ELLENOR, LLC**

The undersigned, being a Manager of 5900 ELLENOR, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is 5900 ELLENOR, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective February 13, 2015, and the Florida document number assigned to this Company is L15000027525.
3. Article IV of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

**"ARTICLE IV
Management of Business**

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.

6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
