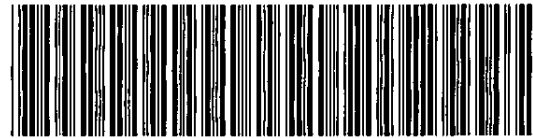

#### ARTICLE II: ADDRESSES




#### **ARTICLE IV: MANAGEMENT**
