ARTICLES OF ORGANIZATION
OF
LLSCOTT HOLDINGS, LLC

The undersigned, pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

ARTICLE I - NAME

The name of the Company is LLSCOTT HOLDINGS, LLC.

ARTICLE II - DURATION

The duration of the Company is perpetual.

The Company shall indemnify each managing Member, manager and officer to the fullest extent permitted by the Florida Limited Liability Company Act.


ARTICLE IX - COMMENCEMENT OF EXISTENCE; EFFECTIVE DATE
