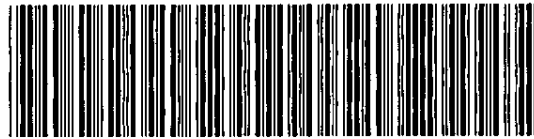

The Company's name is Learning for Life Academy, LLC. The Company is manager-managed.


