**ARTICLES OF ORGANIZATION

The undersigned, **STUDER PROPERTIES, LLP**, a Florida limited liability partnership authorized to contract and the sole member of **OLD STINKY, LLC**, hereby presents these Articles of Organization as the Articles of Organization of **OLD STINKY, LLC**, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is **OLD STINKY, LLC**. This limited liability company is referred to in these Articles of Organization as the "Company."
