Articles of Organization

of

Metro Six Mile, LLC

A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Metro Six Mile; LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
- 4. <u>Place of Business</u>. The mailing address and street address of the Company's principal office is 900 S.W. Pine Island Road, Suite 202, Cape Coral, Florida 33991.
