For the owners best interest here is how we see fit to govern ourselves as owners for All American Standard Home Services, LLC. At Any time with all members votes (agreed upon) we as the body will amend if need be. With this said all partners must be physically present to amend with notarized signatures. The following Items are to govern us and to be utilized as our commandments:
