ARTICLES OF ORGANIZATION OF MANTRA PROPERTY INVESTMENTS, LLC

The undersigned, Kevin Logan, a natural person competent to contract and an authorized representative of a member of Mantra Property Investments, LLC, hereby presents these Afficies of Organization as the Articles of Organization of Mantra Property Investments, IEC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

#### ARTICLE I - NAME

The name of the limited liability company is Mantra Property Investments, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

#### ARTICLE II - PRINCIPAL OFFICE ADDRESS
