The undersigned, Clare T. Wilson, a natural person competent to contract and a member of CT Wilson, LLC, hereby presents these Articles of Organization as the Articles of Organization of CT Wilson, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME
